FORMAT: 36 holes stroke play; 18 holes per day. Saturday will be a shotgun start at 12:00 PM. Sunday will be tee times on holes 1 & 10 at 7:30 AM.

TEES: The Boys Championship Flight will play the Gold tee markers. The Girls Championship and Boys First Flight will play the White tee markers. The Girls First Flight will play the Green tee markers. Some yardages may be moved for the tournament. On the days of the tournament, be sure to play to color tee your flight has been assigned.

RULES OF PLAY: The 2012-2015 USGA Rules of Golf are in effect and are supplemented by the NCGA rules card. The committee will provide any additional Local Rules needed at the tee. It is the individual player's responsibility to know the conditions of the competition.

WALKING: Players must walk at all times, except as authorized by the Committee. Caddies are not permitted. Pull or push carts are permitted. **Spectator carts are prohibited.**

PRACTICE ROUND: Practice rounds tee times may be made by calling the pro-shop at 209-664-6450. Cost of the practice round will be \$25.00 for tournament players. Parents wishing to play will pay the twilight rate of \$35 Monday-Thursday and \$45 Friday-Sunday. This includes the cart fee. Juniors playing with a paying adult can ride for free. Please identify yourself as a participant in the Junior Tour tournament when scheduling a practice round. Discover credit card is not accepted at Stevinson.

WITHDRAWALS AND NO SHOWS: Refer to NCGA Hard Card. Players who enter an NCGA event and wish to withdraw for any reason MUST notify the NCGA Rules and Competitions Department at (831) 625-4653. Failure to notify the NCGA will result in a NO SHOW and the player will receive a ONE-YEAR SUSPENSION FROM ALL NCGA EVENTS FOR THE CALENDAR YEAR FOLLOWING THE INFRACTION. A player who only contacts the course and NOT the NCGA will incur the suspension.

FOOTWEAR: Non-metal spikes required. Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

DRESS CODE: Refer to NCGA Hard Card.

PRO SHOP & RANGE: The driving range will be available starting at 10:30 AM Saturday and 6:30 AM Sunday. There are a limited number of spots so players are asked to limit their practice. Players who have hit an excessive number of balls may be asked to step aside to allow others to warm up.

FOOD SERVICE: A barbecue lunch will be provided before the round on Saturday and following the round on Sunday. Breakfast burritos will be available for purchase on Sunday morning. Parents can purchase the lunch for
