

## Holiday Series I Del Monte Golf Course November 23-24, 2020

## SUPPLEMENTARY LOCAL RULES

## 2020 COVID Guidelines and Policies must be followed. The 2020 USGA Rules apply and are supplemented by the JTNC Hard Card and the following Local Rules.

**Tees: BLUE NCGA** tee markers - Boys Championship Flight; **WHITE NCGA** tee markers - Boys First Flight and Girls Championship Flight; **RED NCGA** tee markers - Girls First Flight

**Format:** 36 hole stroke play tournament; 2 stipulated 9 hole rounds being played each day.

**Score Cards:** The Del Monte scorecard and its local rules are unofficial and have no status.

<u>Obstructions:</u> : Relief from interference by an immovable obstruction may be taken under Rule 16.1. Steel tree supports throughout the course are immovable obstructions. The on-course restrooms are immovable obstructions. The flowerbed surrounded by the stone wall and cart path on holes 6 and 7 is considered part of the cart path and thus an immovable obstruction.

**Protection of Young Trees:** The young trees identified by stakes are no play zones. If a player's ball lies anywhere on the course other than in a penalty area and it lies on or touches such a tee or such a tree interferes with the player's stance or area or intended swing, the player must take relief under rule 16.1f. If the ball lies in a penalty area, and interference to the player's stance or area of intended swing exists from such a tree, the player must take relief either with penalty under Rule 17.1e or with free relief under Rule 17.1e(2).

<u>Elevated Power Lines</u>: If it is known or virtually certain that a player's ball hit a power line (or tower or a wire or pole supporting a power line) during play of Hole 13, the stroke does not count. The player must play a ball without penalty from where the previous stroke was made (see Rule 14.6 for what to do).

**Out of Bounds:** Defined by white stakes. On **hole #8** defined by the split-rail fence and white stakes. The maintenance area is out of bounds. Near the clubhouse, white dots at the curbing define out of bounds.

**Wrong Putting Green:** Relief **MUST** be taken for a ball that comes to rest on the practice putting green or practice chipping green near the 18<sup>th</sup> hole and the "target" greens near the 17<sup>th</sup> fairway in accordance with Rule 13.1f. For the purpose of Rule 13.1f the practice putting green and chipping greens include the apron surrounding them. As an additional option for relief under Rule 13.1f from the chipping green near Hole 18 only, a drop zone has been provided.

**<u>Restrooms on Course</u>**: There are multiple restrooms on the course: at the golf shop; behind the 16<sup>th</sup> teeing ground which is also adjacent to 11 green, 12 teeing ground and nearby to the 1<sup>st</sup> green; and between the 7<sup>th</sup> green and 8<sup>th</sup> teeing ground.

## **Bunkers:** Preferred Lies will be allowed in all Bunkers.

- When a player's ball lies in a bunker, the player may take free relief once by **placing** the original ball or another ball in and playing it from this relief area:
  - o Size of Relief Area Measured from Reference Point: One club-length from the reference point, but with these limits:
  - o Limits on Location of Relief Area:
    - Must not be nearer the hole than the reference point, and
    - Must be in the same bunker.

**Pace of Pay:** Maximum playing time today is 4 hours and 52 minutes, 2:26 Front Nine / 2:26 Back Nine. **Ties/ Play-Off**: All ties will be broken by use of the USGA recommended method of matching scorecards.
