**Notice to Players**

*(This information supplements the Rules of Golf, effective January 2020 and the 2020 JTNC Hard Card)*

**Tee Markers:** Boys Cham. Blue JTNC. Boys First White JTNC. Girls Champ. White JTNC. Girls First Red JTNC.

**Scorecard:** Local Rules on the Pasatiempo GC scorecard are unofficial and have no status in the competition.

**Out of Bounds:** Defined by inside edges at ground level of white stakes, white lines, perimeter fences, by posts of driving range fence on Hole 1, by the golf course side of paved perimeter and interior public roads and culverts on Holes 2, 4, 5, 6, 8 and 9 where stakes or lines are not present.

**Note:** The interior public road between Holes 10 and 16 does NOT define out of bounds. Out of bounds crosses the road at the final blue stakes on each end.

**Code of Conduct – Play of 11<sup>th</sup> and 12<sup>th</sup> Holes:** During the play of the 11<sup>th</sup> or 12<sup>th</sup> holes, a player must not deliberately hit the ball from the teeing area onto the opposite hole. Penalty for Breach: **Disqualification**.

**Opposite Side of a Penalty Area Relief:** Model Local Rule B-2.1 is in effect.

**Immovable Obstructions:**

- a. **Holes 10 and 16:** The road, culvert, split-rail fence, adjacent signs and cart path are all treated as one obstruction. Area is designated by blue stakes.
- b. **Walking paths** are immovable obstructions.

**Ball Deflected by Power Line:** If it is known or virtually certain that a player's ball hit the power line during the play of Hole 6 or Hole 17, the stroke does not count. The player must play a ball without penalty from where the previous stroke was made (MLR E-11).

**Penalty Areas - Dropping Zones:** On the following holes, in addition to the options available under Rule 17.1d for a ball in a penalty area, the player may use the dropping zone under penalty of one stroke:

- a. **Hole 16:** for a ball that last crosses the margin of the red penalty area right of the green;
- b. **Hole 18:** for a ball that last crosses the margin of the yellow penalty area.

**Integral Objects:** Bird feeders attached to trees are integral objects. Free relief is not available.

**No Play Zone:** If a ball lies in or touches this area, or when such condition interferes with the player's stance or area of intended swing, relief **MUST** be taken as prescribed under Rule 16.1f:

- a. **Hole 7:** The turf nursery behind the putting green and all area encircled by the white line. In addition to the relief available under Rule 16.1f, the player may drop a ball in the provided dropping zone.

**Aeration Holes:** Local Rule as prescribed in Section 8 of the Committee Procedures is in effect (MLR E-4).

**Immovable Obstructions Close to Putting Green:** The Local Rule in Section 8 of the Committee Procedures is in effect (MLR F-5). Both the ball and obstruction must lie in a part of the general area cut to fairway height or less; otherwise relief is not available under this Local Rule.

**Ties:** All ties will be broken using the USGA preferred method of matching scores.

**PACE OF PLAY**

**Playing time today is 4 hours 44 minutes for 18 holes with a turn time of 7 minutes.**
